# UPDATES TO GB MODEL EXPORT HEALTH CERTIFICATES (EHCS) FOR ANIMALS AND ANIMAL PRODUCTS

I am writing to inform you that we have made a number of minor revisions to the model health certificates for importing consignments of animals and animal products into Great Britain. Some of these relate to EHCs already in use by EU member states, while others relate to EHCs coming into effect later this year as part of the phased introduction of EHCs for POAOs and ABPs originating from Member States.

Details of these changes can be found in Annexes 1, 2, 3, 4 and 5 and on Gov.UK.

We will allow until the following dates for incorporating the changes listed in each Annex into EU member states' export systems:

- **Annex 1:** Updates to import conditions in live animal and germinal product EHCs, to be implemented by 1 May 2022
- **Annex 2:** Updates to import conditions in live animal and germinal product EHCs, to be implemented by 20 June 2022
- **Annex 3:** Updates to import conditions in regulated animal by-products, meat and meat product EHCs, to be implemented by 1 July 2022 in line with the transitional phasing period for import controls on SPS products

**Annex 4:** Updates to import conditions in dairy product EHCs, to be implemented by 1 September 2022 in line with the transitional phasing period for import controls on SPS products

**Annex 5:** Updates to import conditions in all remaining EHCs for products of animal origin, to be implemented by 1 November 2022 in line with the transitional phasing period for import controls on SPS products

Where future changes are necessary to GB model health certificates, details will be communicated to you in writing and published on Gov.UK. For the majority of updates to our certificates, we will allow a period of up to 6 months from the date of the notification letter for incorporating the changes into your export systems. In specific cases it may be necessary to reduce this period, for example if an urgent change is required to manage an import risk. In these cases, details of the reduced implementation period will be included in the notification letter.

I would appreciate your assistance in cascading the information in the Annexes to all EU member states colleagues.
